**Policy Statement** As part of its public service mission of meeting the educational, recreational, and informational needs of its customers, the Camden County Library charges a fee for certain express services. To fulfill an obligation to the borrowing community at large and to further provide comprehensive customer service, the Library also attaches replacement fees to late, lost, or damaged items.

**Regulations:**

1. Fees for services

3D Printing (by weight)	\$ .05 per gram
Microfilm printouts	\$ .25 per page

Notary Service – County Store, Voorhees Town	\$2.50 per document
Faxes (outgoing and incoming)  The Library can send faxes within the United States, Canada and Mexico	\$1.00 per page (no charge for cover pages)

Laminating	First five (5) sheets free, each additional sheet is \$1.00

2. Registration fees for paid library cards/memberships

3-month membership	\$25.00 per household
6-month membership	\$50.00 per household
1-year membership	\$100 per household

3. Extended use fees

- 3.1 Extended use fees will be assessed on items in high demand collections with short circulation periods and items on loan from other libraries.
- 3.2 There is a one-day grace period for overdue materials that have extended use fees. On the second day, the charge is for two days and accumulates from there.
- 3.3 When an item is 14 days overdue, the patron's account will be suspended from borrowing until the overdue item is returned or paid for. Patrons may sign up to receive reminders by email or text prior to or on an item's due date. The Library will send three overdue notices (after 7 days, 14 days and 34 days), and the patron's account will be billed on the 35th day if the item has not been returned. Interlibrary Loan patrons may receive an adjusted bill when the Library is invoiced for unreturned materials.

4. Fees for damaged or lost materials will be assessed at the list price. When the list price is not available, the following fees, based on current average replacement costs for materials, will apply:

5. Fees for damaged or lost book covers and containers

6. A non-refundable processing fee of \$4.00 will be attached to the charge for all lost and damaged materials, except for a \$10.00 processing fee for museum passes, ukuleles, Squishy Circuits, and portable chargers and Tech Take-Out items listed in this policy.
  
7. Customers who owe more than \$5.00 in extended use or other fees on their accounts may not check out or renew any library materials until the amount owed is reduced to \$5.00 or less or paid off completely.
  
8. The Library Director is authorized to conduct periodic and ongoing sales to the public of discarded and donated books and other library materials and to set reasonable, market-rate prices for these sales.
  
9. Upon prior notification to the Library Commission, the Library Director is authorized to generate revenue through the sale to the public of Library branded items such as book bags and clothing.
